Will announce name of 3rd front soon: Kirorilal

KOTA, FEB 11 /—/ Accusing the Congress and the BJP of not doing much for public welfare during their respective rules, Independent Member of Parliament from Dausa Kirorilal Meena has said a third front is imminent in Rajasthan.

"The people of the state find themselves trapped in corruption, crime and bureaucracy. They are looking for an alternative. We would provide them with an alternative and would announce the name of the third front party on February 28 in Udaipur," Meena told reporters here.

"The party of the third front will field its candidates for all the seats of the state in the upcoming election," Meena said while speaking to reporters here yesterday after attending a 'kisan sammelan (farmers' meet) organised at Kathoon village here.

The third front would seek alliance with Janta Dal (United), communist and other political parties, he said.

YSR Congress (YSRCP) of Y S Jagan Mohan Reddy, the Chief Minister pointed out that Congress had a thumping win in elections even though as many as 150 MLAs quit the party in 1977.

He was addressing a gathering of newly-elected presidents of agriculture cooperative societies from Addanki in Prakasam district, where the sitting Congress MLA moved over to YSRCP.

"If leaders feel that the party is surviving because of me, that is wrong. Workers are the strength of Congress. If old water goes, fresh water comes," a Congress release quoted Kiran Kumar Reddy as saying.

None understood why the Addanki MLA had quit the Congress, he said.

State Municipal Administration Minister M Mahidhar Reddy, who hails from Prakasam district, said Congress activists stood by the party though leaders had ditched it.

Congress' success in cooperative polls proved that point, he said.

Congress Lok Sabha member from Vijayawada L Rajagopal said the party is strong in AP under the leadership of Sonia Gandhi and due to the effective implementation of welfare schemes by the Kiran Kumar Reddy government. (PTI)
